AMENDED JUDGMENT FOR MONETARY RELIEF AS TO DEFENDANT CHRISTOPHER C. WEIDES

Based on the files, records, and proceedings herein, the Court considered the U.S. Securities and Exchange Commission's ("SEC") motion for monetary relief against defendant Christopher C. Weides ("Weides" or "Defendant") [Dkt. No. 151] and rendered an order in the matter and entered judgment against Weides on December 9, 2015 [Dkt. Nos. 184, 185]. The SEC then requested that the Court enter an amended judgment for monetary relief against Weides modifying solely certain procedural aspects regarding the payment of the judgment against Weides [Dkt. No. 186]. After due consideration of the request, IT IS HEREBY ORDERED THAT:

- 1. The Court GRANTS the SEC's request for disgorgement and prejudgment interest against Defendant Christopher C. Weides, but DENIES its request for civil penalties.
- 2. Defendant is liable for disgorgement of \$177,000, together with prejudgment interest in the amount of \$71,752.17.

- 3. Defendant shall satisfy this obligation by paying disgorgement of \$177,000 and prejudgment interest of \$71,752.17 to the SEC within 14 days after entry of this Judgment.
- 4. Defendant may transmit payment electronically to the SEC, which will provide detailed ACH transfer/Fedwire instructions upon request. Payment may also be made directly from a bank account via Pay.gov through the SEC website at http://www.sec.gov/about/offices/ofm.htm. Defendant may also pay by certified check, bank cashier's check, or United States postal money order payable to the SEC, which shall be delivered or mailed to:

and shall be accompanied by a letter identifying the case title, civil action number, and name of this Court; Christopher C. Weides as a defendant in this action; and specifying that payment is made pursuant to this Judgment.

- 5. Defendant shall simultaneously transmit photocopies of evidence of payment and case identifying information to the SEC's counsel in this action. By making this payment, Defendant relinquishes all legal and equitable right, title, and interest in such funds and no part of the funds shall be returned to Defendant. The SEC shall send the funds paid pursuant to this Judgment to the United States Treasury.
- 6. The Commission may enforce the Court's judgment for disgorgement and prejudgment interest by moving for civil contempt (and/or through other collection procedures authorized by law) at any time after 14 days following entry of this Judgment. Defendant shall pay postjudgment interest on any delinquent amounts pursuant to 28 U.S.C. § 1961.

7. The Court shall retain jurisdiction of this matter for all purposes, including, but

not limited to, enforcement of the terms of this Judgment.

8. There being no just reason for delay, pursuant to Rule 54(b) of the Federal Rules

of Civil Procedure, the Clerk is hereby directed to enter this Judgment forthwith and without

further notice.
