This Court, having granted the Plaintiff Securities and Exchange Commission's summary judgment motion, enters this Final Judgment Imposing Disgorgement, Prejudgment Interest, and Civil Penalties ("Final Judgment") against Charles Bayne a/k/a Charles Taylor ("Bayne").

I.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED that pursuant to Section 20(d) of the Securities Act, 15 U.S.C. § 77u(d), and Section 21(d)(3) of the Exchange Act, 15 U.S.C. § 78u(d)(3), Defendant Bayne shall pay civil penalties in the amount of \$120,000. Defendant Bayne shall pay this penalty within sixty days of entry of this Final Judgment by cashier's check, certified check or postal money order. This payment shall be made payable to the United States Treasury and shall be transmitted to the Office of Financial Management, 6432 General Green Way, Stop 0-3, Alexandria, Virginia 22312, under cover of a letter which identifies the defendant, the name and case number of this litigation and the name of the Court. A copy of the cover letter and check shall be simultaneously transmitted to counsel for the Commission at its Los Angeles office, located at 5670 Wilshire Boulevard, 11th Floor, Los Angeles, California 90036.

IT IS HEREBY FURTHER ORDERED, ADJUDGED AND DECREED that Defendant Bayne shall pay disgorgement in the amount of \$955,143 representing ill-gotten gains as a result of the conduct alleged in the Commission's Complaint, together with prejudgment interest. Defendant Bayne shall pay the disgorgement and prejudgment interest within sixty days of entry of this Final Judgment by cashier's check, certified check or postal money order made payable to the United States Securities and Exchange Commission, which check or money order shall be transmitted to the Office of Financial Management, 6432 General Green Way, Stop 0-3, Alexandria, Virginia 22312, under cover of a letter which identifies the defendant, the name and case number of this litigation and the name of the Court.
