NOTICE OF STAY AS TO  
ENTIRE PROCEEDING

I previously stayed this proceeding as to Respondent Chang-On International, Inc., pursuant to the Securities and Exchange Commission's order staying all administrative proceedings assigned to an administrative law judge in which a respondent has the option to seek review in the Tenth Circuit of a final order of the Commission. *Capitol City Bancshares, Inc.*, Admin. Proc. Rulings Release No. 4822, 2017 SEC LEXIS 1509 (ALJ May 23, 2017) (citing *Pending Admin. Proc.*, Securities Act of 1933 Release No. 10365, 2017 SEC LEXIS 1494 (May 22, 2017)). The only other Respondent remaining in this proceeding is Computer Graphics International Inc., which the order instituting proceedings (OIP) alleges is a Nevada corporation located in China, *see* OIP at 2; if Computer Graphics were to seek review of a final Commission order, it could only do so in the Ninth Circuit or the Circuit for the District of Columbia, *see* 15 U.S.C. § 78y(a)(1).

On June 1, 2017, the Division of Enforcement submitted a notice requesting that the proceeding also be stayed as to Computer Graphics to "allow for the most efficient use of this Court's resources." Notice at 1. Even though this matter has been proceeding piecemeal depending on when service has been achieved,<sup>1</sup> because the Commission's order can be read to

require a stay of the entire proceeding, as that term is defined by Rule of Practice 101(a)(9)(i), 17 C.F.R. § 201.101(a)(9)(i), I will grant the Division's request. The proceeding is also STAYED as to Computer Graphics.
