



My name is Douglas Meyer, I am a holder of ATP common shares and ATP preferred shares. ATP had file Chapter 11 protection and now that filing has been converted to Chapter 7. This bankruptcy is unlike most as the court documented cause was the "Deepwater Horizon Explosion in the Gulf of Mexico". As a result ATP has filed suit against 11 defendants in the Fifth Circuit, Louisiana Eastern District, New Orleans; Case number 2:2013cv01962, Judge Carl Barbier.

In January 2013, ATP, with the assistance of the Firms, submitted a claim to BP under the Oil Pollution Act of 1990 for loss of profits and earning capacity as a result of the Deepwater Horizon Spill in an amount not less than \$3,011,534,889.00 (the "OPA Claim"). (Court document 1575) With ATP losing \$3 billion dollars of asset value through the course of the Chapter 11 proceedings, that claim could grow to over \$6 billion dollars. If ATP should win this suit in court, all creditors should get paid in full and the award would leave a substantial balance to the equity holders of ATP, the owners of ATP if you will. This fact makes this bankruptcy filing unique.

The issue today is **Delinquent Periodic Filings by ATP** management. I have no excuse for this management team as they had the fiduciary responsibly to equity holders to insure filings were done according to law. As **equity holders we have had access to monthly financial filings through Monthly Operating Reports filed with the Bankruptcy Court** in Houston. These filing were public records and subject to the force of law. That Monthly Filing record is attached for your information and review if you deem acceptable.

More concerning to me today is equity holders "due process rights" in the converted Chapter 11 to Chapter 7 case. I do understand this is not the responsibility of the SEC but wouldn't to go on the

record with my concerns. Our elected board of directors all resigned prior to the Chapter 7 conversion. The only active board member is the Court appointed CRO, Chief Restructuring Officer. As ATP has lost \$3 billion dollars of asset value in the Chapter 11 process, with only one post-petition creditor getting paid and that creditor is still owed over \$200 million dollars. Pre-petition Second lien holders and per-petition creditors have not been paid one dime which has been concerning to me as an equity holder. With the BP claim and suit unresolved in the courts, Equity Holders need their "due process rights" protected along with the value of this claim. That protection starts with the fiduciary responsibly of the board of directors to equity holders. New board members need to be appointed to replace those members that have resigned as the corporations Articles of Incorporation and By-laws require. Without this "due process protection" other parties to this bankruptcy might force a settlement in the BP case, that forced settlement might only benefit them, leaving equity holders without the opportunity to make the corporation whole again. As the SEC's has a role in protecting "public" shareholders rights, I wanted to voice my concerns and point out that ATP Oil and Gas might be made whole again, if their suit is won in the U. S. courts.
