DECLARATION OF NEIL J. WELCH, JR. TO ASSIST SECRETARY WITH RECORD OF SERVICE

NEIL J. WELCH, JR., pursuant to 28 U.S.C. § 1746, declares:

- 1. I am a Senior Investigations Counsel with the Division of Enforcement ("Division") of the Securities and Exchange Commission, and co-counsel for the Division in the above-captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the respondents in the above-captioned proceedings pursuant to Rule 141(a)(3).
- 2. The Office of the Secretary provided me with the Priority Mail Express tracking numbers for the copies of the Order Instituting Proceedings ("OIP") that were mailed by the Secretary to the respondents in this proceeding. I input each of the tracking numbers into the U.S. Postal Service's package tracking system on its Internet website located at www.usps.com, and printed out the tracking confirmations in order to obtain confirmation of the delivery or attempted delivery of the OIP on each respondent. Rule 141(a)(2)(ii) provides that service on a corporation or entity may be obtained by

confirmation of attempted delivery on the most recent address shown on the entity's most recent filing with the Commission.

- 2. The Secretary mailed the OIP to respondent Agent155 Media Corp. (CIK No. 1389405) via Priority Mail Express, Label Tracking No. to the address shown on its most recent EDGAR filing of The USPS tracking system confirms that delivery was attempted on February 28, 2015.
- 3. The Secretary mailed the OIP to respondent QSound Labs, Inc. (CIK No. 840518) via Priority Mail Express, Label Tracking No. 10 to the address shown on its most recent EDGAR filing of 11. Both Canada and the United States are signatories to the Hague Convention on the Service Abroad of Judicial and Extrajudicial Documents in Civil or Commercial Matters (the "Hague Convention"), 20 U.S.T. 361, T.I.A.S. 6638, 658 U.N.T.A. 163 (1964). Article 10(a) of the Hague Convention provides that, unless the country of destination objects, parties may send judicial documents directly to persons abroad through postal channels. Canada does not object to such service. *Randolph v. Hendry*, 50 F. Supp.2d 572, 578 (S.D.W.Va. 1999).
- 4. The Secretary mailed the OIP to respondent STEN Corp. (CIK No. 350557) via Priority Mail Express, Label Tracking No. to the address shown on its most recent EDGAR filing of The USPS tracking system confirms that delivery was made on March 2, 2015 in

Hopkins, MN, the preferred city name for zip code 55305. A true copy of the tracking confirmation is attached hereto as Exhibit 3.
