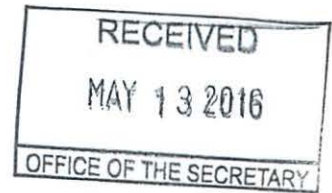



**MOTION BY THE DIVISION OF ENFORCEMENT
AND DAVID PROLMAN TO STAY PROCEEDINGS
AS TO DAVID PROLMAN PURSUANT TO RULE 161(c)(2)**


On May 6, 2016, counsel for the Division of Enforcement ("Division") and Respondent David Prolman reached an agreement in principle to a settlement in this matter. Accordingly, the Division and Mr. Prolman respectfully move for a brief stay of the proceedings as to Mr. Prolman, pursuant to Rule 161(c)(2) of the Commission's Rules of Practice, pending completion of the Commission's consideration of Mr. Prolman's settlement offer. Rule of Practice 161(c)(2) provides that upon filing of a joint motion notifying the hearing officer that the Division and one or more respondents have reached an agreement in principle on all major terms, the hearing officer shall grant a stay of the proceeding as to the settling respondent, pending completion of Commission consideration of the settlement offer.

The Division filed its motion for summary disposition as to all respondents on May 6, 2016. Opposition briefs are currently due on May 20, 2016. The Division and Mr. Prolman therefore request a stay of the proceedings as to Mr. Prolman, so that he may be relieved of the obligation to oppose the Division's motion pending completion of Commission consideration of the settlement offer. The hearing in this matter is not scheduled until August 30, 2016, and the parties are not required to exchange exhibits and witness lists until July 26, 2016. The Division expects to have finality with respect to Mr. Prolman's settlement offer far enough in advance of that July deadline such that there is no need to postpone the hearing or the pre-hearing deadlines.


