DECLARATION OF GINA JOYCE TO ASSIST SECRETARY WITH RECORD OF SERVICE

GINA JOYCE, pursuant to 28 U.S.C. § 1746, declares:

- 1. I am a Senior Counsel with the Division of Enforcement ("Division") of the Securities and Exchange Commission, and co-counsel for the Division in the captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the Respondent in the captioned proceedings pursuant to Securities and Exchange Commission ("Commission") Rule of Practice 141(a)(3).
- 2. Among other means, Commission Rule of Practice 141(a)(2)(ii) permits service on a corporation or entity by delivering a copy of an Order Instituting Administrative Proceedings ("OIP") to an agent authorized by appointment or law to receive such service or, in the case of an issuer with a class of securities registered with the Commission, by sending the OIP via U.S. Postal Service certified, registered, or Express Mail and obtaining a confirmation of attempted delivery on the most recent address shown on the entity's most recent filing with the Commission. Rule

141(a)(2)(iv) of the Commission Rules of Practice provides that "[n]otice of a proceeding to a person in a foreign country may be made by any method specified in paragraph (a)(2) of this rule, or by any other method reasonably calculated to give notice, provided that the method of service used is not prohibited by the law of the foreign country."

(Emphasis added).

- 3. The last Edgar filing by Respondent World Moto, Inc. ("FARE") was a Form 10-Q filed on September 7, 2017, which provided an address for FARE in Bangkok, Thailand. A true copy of a printout of the first page of Form 10-Q filed on September 7, 2017 is attached hereto as Exhibit 1.
- 4. Given the global Covid-19 pandemic and that the Office of International Affairs confirmed that Thailand is not a signatory to the Hague Convention on the Service Abroad of Judicial and Extrajudicial Documents, I determined not to ask the Secretary to attempt to serve FARE at its Bangkok address.
- 5. As shown in Exhibit 1, Respondent FARE is a Nevada corporation. A search of the website of the Nevada Secretary of State revealed that the name and address of FARE's registered agent is Registered Agents, Inc., 401 Ryland St., Suite 200-A, Reno, NV 89502. A true copy of a printout of the summary pages of FARE's corporate status pages from the website of the Nevada Secretary of State are attached hereto as Exhibit 2. Therefore, the Division provided the registered agent's address to the Secretary and requested that the Secretary attempt service on FARE's Nevada registered agent via U.S. Priority Mail Express.
- 6. The Secretary mailed the OIP to FARE's registered agent at the address referenced above via U.S. Priority Mail Express, Tracking No. ER 006 859 512 US. My

search of the USPS tracking system, at www.usps.com, confirmed that the package was delivered on July 29, 2020. A true copy of the tracking confirmation is attached hereto as Exhibit 3.

I declare under penalty of perjury that the foregoing is true and correct.
