The Division of Enforcement ("Division") provides the following status report in the abovereferenced matter:

- 1. On December 21, 2020, the Commission instituted this proceeding with an Order Instituting Administrative Proceedings Pursuant to Section 203(f) of the Advisers Act and Section 15(b) of the Exchange Act and Notice of Hearing ("OIP").
- 2. On January 11, 2021, Sood submitted an Answer to the OIP in which he admitted to his criminal conviction and his association with an investment adviser and broker-dealer during the pertinent period.
- 3. On March 1, 2021, the Commission issued a scheduling order authorizing the Division to file a motion for summary disposition by April 30, 2021. The scheduling order was limited to an agreed briefing schedule on the motion for summary disposition.
 - 4. On April 29, 2021, the Division filed a motion for summary disposition.
- 5. On May 31, 2021, Respondent responded to the motion. Respondent has also requested oral argument.
 - 6. On June 10, 2021, the Division filed a reply in support of the motion.

7. Accordingly, the Division's motion for summary disposition was fully briefed as of June 10, 2021, and the matter is ripe for decision.
