## Motion for Hearing


I just received the fourth motion for a continuance in the case listed above. I have asked repeatedly for an expedited decision in this case due to my age, now 75, and other health issues.

As the Commission knows, FINRA has accused me and my company, Dakota Securities Intl., of felony charges, namely falsifying financial documents. I and my company have suffered the ultimate punishment which is a bar from the industry. I am asking the commission to go to Google and put in my name, Bruce Zipper. After reviewing this case if the Commission believes that is what FINRA has done in this case than please make that ruling and let me please go to Court and try my case there. Who is suffering with this extreme delay for a ruling in this case? Is it FINRA? Is it the Commission? NO, it is me and my family only. NOT FAIR. Please help me. I am pleading for a ruling. And the most important ruling I want to see is who is telling the truth as to if Bruce Zipper is guilty of falsifying Dakota's financial records. Is it Zipper or is it FINRA who I have shown this Commission lied in it's briefs to allow them to use the word FALSIFYING. I wonder how any of you at the Commission would feel if accused of falsifying financial documents for all the world to see and then imagine it was all a LIE! That is what I and my family must live with each day. I am going to prove this in Federal Court! I will be there with the people who FINRA accused me of falsifying their financial records. You know, the ones FINRA called to see if I got their permission to do so. We will see what the judge says after hearing their testimony. They and I can't wait. All I am asking the commission to do is Rule so I can get that chance while I am still alive. That is my motion.
