STATUS REPORT

On September 7, 2022, the Securities and Exchange Commission (the "Commission") issued an Order Instituting Proceedings ("OIP"), pursuant to Section 12(j) of the Securities Exchange Act of 1934, against Energem Resources, Inc. f/k/a DiamondWorks Ltd. ("Respondent" or "Energem").

The Commission's Office of the Secretary served the Canadian address from Energem's last Form 20-F by express mail in September 2022. The Division of Enforcement (the "Division") attempted to deliver the OIP to the South African address from Energem's Form SC 13D/A in November 2022, but the "Customer [was] not available or [the] business [was] closed." *See* Status Report dated November 14, 2022.

On March 24, 2023, the Commission issued an Order Regarding Service asking the Division to address "whether service by this method-*i.e.*, service by U.S. mail with confirmation of attempted delivery-is prohibited by South African law."

Attached as Exhibit 1 is the Affidavit of Jonathan Sahli, an attorney based in South Africa who has been admitted as an attorney of the South African High Court for over 17 years, is the the Co-Head of the Litigation Practice at Bowmans, an international law firm, has extensive experience in cross-border litigation, and has knowledge of South African law on service of process. In his Affidavit, Mr. Sahli opines that service of process originating from the United States to a resident of South Africa through postal channels, where service is deemed complete upon confirmation of attempted delivery, is not prohibited by South African law. Therefore, the Division asserts that service was effected upon Respondent pursuant to Rule 141(a)(2)(iv)(A) of the Commission's Rules of Practice.
