**DECLARATION OF GINA JOYCE CONCERNING SERVICE
OF PROCESS ON GOSUN COMMUNICATIONS LIMITED INC.**

1. I am a Senior Counsel in the Division of Enforcement (“Division”) and co-counsel for the Division in the above-captioned proceeding. I am submitting this Declaration concerning the service of the Order Instituting Proceedings (“OIP”) on Gosun Communications Limited Inc. (CIK No. 832100) (“Gosun” or “Respondent”) in this proceeding.

2. I reviewed the last EDGAR filing made by Gosun, which was a Form 10QSB, filed with the Commission on February 3, 2003. That filing gave an address in Guangzhou, China for the company. China is a signatory to the Hague Convention, but does not recognize service by mail. Therefore, given the expense and delays inherent in perfecting service via the Chinese Central Authority, the Division elected to seek other means of perfecting service on Gosun. Gosun is a Texas corporation. Therefore, I conducted a search of the Texas corporate records using the LexisNexis subscription-based online research system. A true copy of a printout of that LexisNexis system result is attached as Exhibit 1.

3. Exhibit 1 shows that Gosun has a forfeited corporate status under Texas law, and shows that it had a registered agent in Texas at one time. However, once Gosun became a

forfeited corporation, the registered agent relationship ceased to exist. *See Racusin v. Monteco, Inc.*, No. 01-95-00271-CV, 1996 WL 443730, at *2 (Tex. App. Aug. 8, 1996) (“because Intercon's charter had been forfeited one and a half years before this suit was filed, service upon its registered agent was not in accordance with Tex. Bus. Corp. Act Ann. art. 8.10.”). Therefore, the Division asked the Office of the Secretary to send a copy of the OIP to Gosun’s address in China via Registered Mail. The Secretary mailed the OIP to Respondent via Registered Mail, Tracking No. RE 428 754 673 US. The United State Postal Service tracking system at www.usps.com confirms that the OIP is still in transit as of October 31, 2023. A true copy of the USPS tracking confirmation is attached hereto as Exhibit 2. However, as set forth above, China does not recognize service by mail.

4. Texas states that service of process upon a Texas corporation may be perfected by serving the Secretary of State. *See Texas Business and Commerce Code §302.108 and Rule 71.21 of the Texas Secretary of State’s administrative rules.* Service on the Texas Secretary of State is an effective and complete means of serving process on the corporation.

5. I reviewed the last 10KSB filed with the Commission on April 22, 2002. Based on that review, Gosun, at that time, had no officers, directors, or places of business in the State of Texas, or elsewhere in the United States. In fact, Gosun’s 2002 Form 10KSB indicates that Gosun had no corporate presence in Texas or elsewhere in the United States. I determined that service should be made by serving the Texas Secretary of State.

6. The Division retained a professional process server who, on October 25, 2023, perfected service on Gosun by delivering Texas Form 2401 and two identical copies of the OIP in this matter, along with the party letter from the Office of the Secretary, and the Division’s letter offering discovery pursuant to SEC Rule of Practice §201.230, in addition to the \$55 service fee

made payable to the Texas Secretary of State. A true and correct copy of the Declaration of the Process Server is attached hereto as Exhibit 3.

I declare under penalty of perjury that the foregoing is true and correct.




