DECLARATION OF SANDHYA C. HARRIS
TO ASSIST SECRETARY WITH RECORD OF SERVICE

SANDHYA C. HARRIS, pursuant to 28 U.S.C. § 1746, declares:

1. I am a Senior Counsel with the Division of Enforcement (“Division”) of the Securities and Exchange Commission, and co-counsel for the Division in the captioned administrative proceeding. I am submitting this Declaration to assist the Secretary in maintaining a record of service on the respondent in the captioned proceeding pursuant to Rule 141(a)(3).
2. The Office of the Secretary provided me with the U.S. Certified Mail tracking number for the copy of the Order Instituting Proceedings (“OIP”) mailed by the Secretary to the respondent in this proceeding. Rule 141(a)(2)(ii) provides that service on a corporation or entity may be obtained by confirmation of attempted delivery on the most recent address shown on the entity’s most recent filing with the Commission.
3. I input the Certified Mail tracking number provided by the Office of the Secretary into the U.S. Postal Service’s (“USPS’s”) package tracking system on its Internet website located

at www.usps.com, in order to obtain confirmation of the delivery or attempted delivery of the OIP on the respondent, however the tracking information failed to confirm whether a delivery attempt had been made before the package was returned to sender.

4. In order to perfect service, I mailed another copy of the OIP, via Priority Mail Express, to respondent ZENERGY, INC., CIK 1568875 (“ZNRG”), Tracking No. EJ127657221US, to the address shown on its most recent EDGAR filing at 1120 N. Main St. Elkhart, IN 46514. This address is taken from ZNRG’s last filing with the Commission, which was a Form 8-K filed with the Commission on October 19, 2022. The USPS tracking system confirms that delivered on November 1, 2023. *See* Exhibit 1 at page 1.

I declare under penalty of perjury that the foregoing is true and correct.

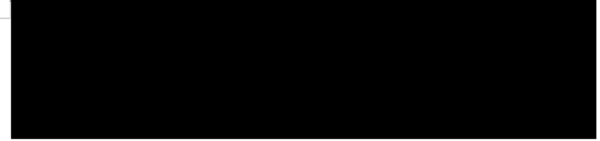
