RESPONDENT'S REPLY

Paragraph 1. Respondent Major League Football Inc. ("MLFB" or "Respondent")(CIK1308569) is not a void Corporation but admits that it is delinquent in its required filings.

Paragraph 2. MFLB's address has always been 15515 LEMON FISH DRIVE, LAKEWOOD RANCH FL 34202 and its phone number has not changed either. MFLB was never officially served with this administrative proceeding but was instead notified of it by an investor. MLFB has confirmed the administrative proceeding and downloaded a copy from the SEC's website.

Paragraph 3. MLFB admits it is delinquent in its required filings as represented in this matter. Its violation of Section 13(a) and Rules 13a-1 and 13a13 is due to a lack of sufficient working capital and is not due to intentional dereliction of duty. MLFB's internal CFO and external consulting CPA with over 25 years of experience, have maintained accurate books and records as required. However, MLFB cannot commence the review and audit work with its PCOAB Auditor until the Auditor is paid in full for prior services. MLFB remains a start-up company and has been unable to field a football league due to a lack of capital.

MLFB is anticipating a bridge loan of \$250,000 this week from a group of investors. Once it receives these funds, its top priority is to complete the required reviews and audits to become current on its SEC filings.

While an inability to pay is usually not grounds for punishment in the United States, Respondent is willing to cooperate with the SEC Division of Enforcement in bringing itself into compliance.
