## ORDER

The Securities and Exchange Commission ("Commission") issued an Order Instituting Proceedings ("OIP") on September 23, 2020, against LHI Acquisition Corporation, n/k/a Xeed Holdings Group, Inc ("Respondent"), pursuant to Section 12(j) of the Securities Exchange Act of 1934.<sup>1</sup> On May 25, 2021, the Division of Enforcement filed a Declaration of Sandhya Harris, which established that, pursuant to Commission Rule of Practice 141(a)(2)(ii),<sup>2</sup> service of the OIP was made on Respondent on September 25, 2020. Accordingly, on June 8, 2021, we ordered Respondent to show cause why the registration of its securities should not be revoked by default due to its failure to file an answer and to otherwise defend this proceeding.<sup>3</sup>

However, the Division's Declaration was not itself accompanied by a certificate of service, as required by Rule of Practice 151(d).<sup>4</sup> The show cause order directed the Division to cure that deficiency.<sup>5</sup> To date, no such certificate of service has been filed.
