Notice of application for an order ("Order") under sections 17(d) and 57(i) of the Investment Company Act of 1940 (the "Act") and rule 17d-1 under the Act to permit certain joint transactions otherwise prohibited by sections 17(d) and 57(a)(4) of the Act and rule 17d-1 under the Act.

<u>Summary of Application</u>: Applicants request an order to permit certain business development companies ("BDCs") and closed-end management investment companies to co-invest in portfolio companies with each other and with certain affiliated investment entities.

<u>Applicants</u>: Monachil Credit Income Fund, Monachil Capital Partners LP, Monachil Credit Partners Master Fund I LP, and Monachil Credit Partners Master Fund II LP.

<u>Filing Dates</u>: The application was filed on December 20, 2023 and amended on March 19, 2024, and April 25, 2024.

Hearing or Notification of Hearing: An order granting the requested relief will be issued unless the Commission orders a hearing.
