Notice of application for an order pursuant to sections 17(d) and 57(i) of the Investment Company Act of 1940 (the "Act") and rule 17d-1 under the Act to permit certain joint transactions otherwise prohibited by sections 17(d) and 57(a)(4) of the Act and rule 17d-1 under the Act.

<u>Summary of Application</u>: Applicants request an order to permit certain business development companies ("BDCs") and closed-end management investment companies to co-invest in portfolio companies with each other and with certain affiliated investment entities.

<u>Applicants</u>: Felicitas Private Markets Fund, Skypoint Capital Advisors, LLC, Felicitas Global Partners, LLC, Felicitas SA1, LP, Felicitas Secondary Fund II, LP, Felicitas Tactical Opportunities Fund, LP, and Felicitas Debt Fund, LP.

<u>Filing Dates</u>: The application was filed on April 6, 2023, and amended on September 11, 2023, May 17, 2024, June 18, 2024, and August 7, 2024.
