DECISIONS IN ADMINISTRATIVE PROCEEDINGS

SCOTT, GORMAN, O'DONNELL & CO.
AND OFFICER SANCTIONED

LIBRARY

The Commission has revoked the broker-dealer registration of Scott, Gorman, O'Donnell & Co., Inc., of New York City, barred James O'Donnell, its president, from association with any broker, dealer, investment adviser or investment company, suspended Richard Curotto, vice president and secretary-treasurer, from any such association for 6 months effective June 23, and barred Curotto from any such association in a supervisory or proprietary capacity. After 15 months, O'Donnell may apply to the Commission to become associated with a broker or dealer in a non-supervisory, non-proprietary capacity. And after 3 years from the termination of his suspension, Curotto may apply to the Commission for relief from his bar as a supervisor or proprietor.

The sanctions were based on findings that, in a 1972 registered offering of common stock of Power Conversion, Inc., the firm and O'Donnell misstated the offering price and failed to disclose the true method of distribution and all of the underwriters. All of the respondents were found responsible for the failure of the firm's books and records to reflect the true owners of Power stock purchased and sold through the firm, and the firm's failure to amend its application for broker-dealer registration to disclose that a certain individual was a controlling person of the firm.

Without admitting or denying the charges against them, respondents consented to the above findings and the indicated sanctions. (Rel. 34-11462)

COMMISSION ANNOUNCEMENTS

REQUEST UNDER THE FREEDOM OF INFORMATION ACT

The Commission denied the appeal of Dow Jones & Co., Inc. and Mr. Ken Bacon from the denial of their request for access to the Commission's investigatory file relating to Phillips Petroleum Co. An injunctive action brought by the Commission against Phillips and certain individual defendants has resulted in the entry of permanent injunctions by consent against all defendants. However, the Commission's inquiry concerning the scope of the violations involved and the persons responsible therefor is continuing. In addition, under the terms of the order of permanent injunction entered against Phillips, Phillips will conduct its own investigation, make a public report on the results and take appropriate remedial action. The Commission has reserved the right to seek such further relief against the company as may appear appropriate. In these circumstances, disclosure of the records which comprise the Commission's investigatory file relating to Phillips appears likely to interfere with pending or prospective law enforcement proceedings. TRADING SUSPENSIONS

WINNER INDUSTRIES TRADING SUSPENSION TERMINATED

The SEC announced on June 18 that the suspension of over-the-counter trading in the securities of Winner Industries, Inc. (Winner) will terminate at midnight (EDT) on June 21, 1975.

The Commission initiated the trading suspension on April 18, 1974, because of the lack of adequate and accurate information about Winner's financial condition and operations. In addition, there was no public disclosure or comment by Winner concerning an involuntary petition in bankruptcy filed in the U.S. District Court for the District of Arizona in January 1974. Other questions were raised concerning the reliability of an announcement which was made by Winner during early 1974.

The staff of the Commission has been recently informed that Winner is not actively engaged in any business activity and that its assets are minimal. In addition, there is no current financial or other information which is available regarding Winner. (Rel. 34-11486)

A notice has been issued giving interested persons until July 11 to request a hearing on an application by Schroder Naess & Thomas and affiliated companies for an order by the Commission exempting them from the provisions of Section 9(a) of the Investment Company Act of 1940 operative as a result of an injunction entered against Schroder Naess & Thomas in SEC v. F. L. Salomon & Co., et al. (Rel. IC-8828 - June 18)
