## RULES AND RELATED MATTERS

## LIBRARY

### MAXIMUM SALES LOAD RULE PROPOSED

The Commission announced today that it was publishing for comment the proposed NASD maximum sales load rule, in accordance with the statutory requirements of Section 19(b) of the Securities Exchange Act of 1934, as recently amended by the Securities Acts Amendments of 1975. As proposed, the rule would permit mutual funds or single payment contractual plans to charge a maximum sales load of 8.5% (declining to 6.25% for larger purchases) but would condition the right to charge the maximum on the fund's offering (1) dividend reinvestment at net asset value (2) rights of accumulation, and (3) volume discounts, as defined in the proposed rule. The rule would also specify maximum sales loads ranging from 8.50% down to 6.50% for variable annuity separate accounts.

Copies of the complete NASD filing and all written submissions will be available for inspection in the Commission's Public Reference Room, 1100 L Street, N.W., Washington, D.C., and at the principal office of the NASD, 1735 K Street, N.W., Washington, D.C. 20006.

Interested persons are invited to submit written data, views and arguments concerning the proposed rule, and should file six copies of any written submission with the Secretary of the Commission, Securities and Exchange Commission, Washington, D.C. 20549, File No. SR-13, to be received no later than 15 days after publication of the proposed rule in the Federal Register. ## DECISIONS IN ADMINISTRATIVE PROCEEDINGS

### S. J. SALMON & CO., INC., SHELDON SALMON, WILLIAM A. HELMAN AND JEROME TRUEN SANCTIONED

The Commission has revoked the broker-dealer registration of S. J. Salmon & Co., Inc., of New York City, and barred Sheldon Salmon and William A. Helman, who were officers of Salmon Co., from association with any broker or dealer. It also barred Jerome Truen, who was an undisclosed principal of the firm, from association with any registered broker, dealer or investment company.

The sanctions imposed were based on findings that, from January 1969 to February 1972, respondents engaged in various fraudulent and manipulative activities in connection with securities transactions. They effected transactions in 26 stocks to create trading and raise artificially the prices of such securities; induced customers to purchase such securities at excessive and unreasonable prices; and entered into repurchase and block swap arrangements with various broker-dealers. In addition, respondents required the firm's salesmen to effect transactions for customers without their prior authorization, to "tie-in" the purchase of one security with the purchase of others for the purpose of manipulating the market, and to discourage or refuse to accept and/or execute customers orders to sell the securities.

It was also found that respondents made misstatements in the public offerings of nine of the stocks with respect to the manner and method of distribution. It was further found that while participating in the distribution of securities on a "best efforts all or none" underwriting basis, Salmon Co. failed to deposit promptly in a separate bank account as agent for the purchasers all the money or other consideration received from them. And Salmon Co., aided and abetted by Salmon, Helman and Truen, were also found to have violated the Securities Exchange Act's net capital, reporting, record-keeping and credit-extension provisions.

Without admitting or denying the charges, respondents consented to the indicated findings and sanctions. (Rel. 34-11576)

➤ **PITT TO SUCCEED NERHEIM ON SEPT. 1;  
FERBER BECOMES SOLICITOR TO SEC**

Chairman Ray Garrett, Jr., today announced that, effective September 1, 1974, Harvey L. Pitt, presently Deputy General Counsel to the Commission, will become its General Counsel, and David Ferber, presently Solicitor in the Office of the General Counsel, will become Solicitor to the Commission. Mr. Pitt succeeds Lawrence E. Nerheim, who has resigned as General Counsel effective August 31, 1975, to return to the private sector.

In view of the increased burden of appellate litigation and the increased responsibilities recently assumed by the Office of the General Counsel, Mr. Ferber will assume final staff responsibility for the preparation of the Commission's appellate briefs.

**HEARING SET RE CONNECTICUT LIGHT & POWER AND  
HARTFORD ELECTRIC LIGHT PROPOSED ACQUISITION  
OF CONNECTICUT NATURAL GAS PROPERTIES**

The Commission has ordered a hearing to be held on September 17, 1975, at 10:00 a.m. at the SEC Headquarters Office, 500 North Capitol Street, N.W., Washington, D.C., on a proposal by CL&P and HELCO, subsidiaries of Northeast Utilities, to sell their gas utility properties to the Connecticut Natural Gas Corporation and to the Town of Wallingford, Connecticut. A prior proceeding with respect to these properties (see 42 SEC 963 (1966)) has been reinstated and consolidated for hearing with the CL&P and HELCO proposals. Motions to dismiss or defer all proceedings have been denied. (Rel. 35-19125 - Aug. 13)

## TRADING SUSPENSIONS

---

**CHILL CAN INDUSTRIES, SYSTEMATIC TAX SUSPENDED**

The SEC announced the suspension of over-the-counter trading in the securities of Chill Can Industries, Inc., a Florida corporation located in Columbus, Ohio, and Systematic Tax, Inc., a Delaware corporation located in Chicago, Illinois, for the ten-day period beginning on August 14 and terminating at midnight (EDT) on August 23, 1975.

In the case of Chill Can, the suspension was ordered because of the unavailability of adequate and accurate information about the corporation and its financial condition and operations. Chill Can Manufacturing Company, owner of all substantial assets of Chill Can Industries, Inc., is currently non-operational, insolvent and in Oklahoma State Court receivership.

The Systematic Tax suspension was initiated because of questions about the recent market activity in the company's securities. (Rel. 34-11566 (Systematic); 34-11594 (Chill Can)).

**ADDITIONAL ACTION ON TWO TRADING SUSPENSIONS**

The SEC has announced the suspension of (a) exchange and over-the-counter trading in the securities of Canadian Javelin Ltd. for the further ten-day period August 17 - 26, inclusive; and (b) exchange and over-the-counter trading in the securities of Continental Vending Machine Corp. for the further ten-day period August 18 - 27, inclusive.

## ORDERS FOR PUBLIC PROCEEDINGS

---

**STEPHEN SMITH, OTHERS**

Administrative proceedings have been ordered against Stephen Smith, chairman of the board of Smith, Jackson & Co., Inc.; Roger Nieman; Richard Peress; William Dix; Edward Kessler; Bell & Beckwith, a registered broker-dealer located in Toledo, Ohio; Grafton Mouen, a general partner of Bell & Beckwith; and Banque de Paris et des Pays-Bas, a Swiss Bank.

The information leading to these proceedings was developed as a result of the joint SEC-NASD Task Force effort. It is alleged by the Commission's staff that respondents Smith, and Banque de Paris wilfully violated and wilfully aided and abetted violations of the antifraud provisions of the securities laws, and that Bell and Beckwith, Mouen,

Kessler, Nieman and Peress wilfully violated and wilfully aided and abetted violations of the antifraud provisions of the securities laws in the purchase and sale of Pelorex Corp. securities.

The charges allege, among other things, that the Banque de Paris withheld a large proportion of the original offering of Pelorex Corp. from the public market and in concert with Smith was thereby able to artificially limit the available supply of Pelorex stock from the outset of the offering. The Banque de Paris is also charged with reselling a proportion of the stock withheld at a later date at a substantial profit.

A hearing will be scheduled by further order to take evidence on the staff's allegations and to afford the respondents an opportunity to offer any defenses thereto, and for the purpose of determining whether the allegations are true and, if so, whether any action of a remedial nature are appropriate in the public interest.
