COMPLAINTS NAME SIX; THREE CONSENT TO ORDERS  
TO FILE TIMELY FORMS 4

The Commission filed six civil actions on July 23 in the U.S. District Court for the District of Columbia requesting Final Orders requiring John Keogh, Mark H. Lee, John E. Wertin, Benjamin N. Woodson, one bank trustee, Bank of America N.T. & S.A., and one employee profit sharing fund, The Savings and Profit Sharing Fund of Sears Employees, to file timely Form 4 Statements of Changes in Beneficial Ownership of Securities as required by Section 16(a) of the Securities Exchange Act of 1934. Final Orders were entered in three of the actions based upon the consents of the bank trustee, the employee profit sharing fund, and Woodson. These three defendants consented to the Final Orders without admitting or denying the allegations in the complaints. (SEC v. ### NOTICE OF PROPOSED RULE CHANGE

The Depository Trust Company filed a proposed rule change (SR-DTC-84-3) to allow municipal securities brokers and dealers to use its communications facilities to submit trade data to, and receive comparison output from, National Securities Clearing Corporation's Municipal Bond Processing System. The proposal is being implemented as a pilot project pending final Commission determination. Publication of the proposal is expected to be made in the Federal Register during the week of July 23. ## ACQUISITIONS OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.

Below is a list of recent filings of Schedules 13D and 14D, which includes the following information: Column 1 - the company purchased (top), and the name of the purchaser; Column 2 - the type of security purchased; Column 3 - the type of form filed; Column 4 - the date the transaction occurred; Column 5 - the current number of shares (in 000's) owned (top) and the current percent owned; Column 6 - the CUSIP number (top) and the prior percent owned; and Column 7 - the status of the filing, i.e., new, update, or revision.
