## ADMINISTRATIVE PROCEEDINGS

---

### ENERDINE INTERNATIONAL CORPORATION REVOCATION PROCEEDINGS ORDERED

The Commission ordered public administrative proceedings under Section 12(j) of the Securities Exchange Act of 1934 to determine whether the registration of Enerdine International Corporation common stock under Section 12(g) of the Exchange Act should be revoked for Enerdine's failure to file reports as required by Section 13(a) of the Exchange Act for over two and one-half years.

On April 20, 1983, a Default Judgment and Permanent Injunction was entered against Enerdine by the U.S. District Court for the District of Columbia. On October 5, 1983, under Consents, Findings of Civil Contempt and an Order of Contempt were entered against Enerdine and its President, James J. Flood [SEC v. Enerdine International Corp., USDC DC, Civil Action No. 82-2803]. (Rel. 34-21620)

## INVESTMENT COMPANY ACT RELEASES

### THE MITSUI BANK OF CANADA

A notice has been issued giving interested persons until January 31 to request a hearing on an application filed by The Mitsui Bank of Canada for an order exempting it from all provisions of the Investment Company Act so that it may offer U.S. dollar-denominated certificates of deposit and other debt securities in the United States. ## HOLDING COMPANY ACT RELEASES

### CONSOLIDATED NATURAL GAS COMPANY

An order has been issued authorizing a proposal by Consolidated Natural Gas Company, a registered holding company, and its subsidiary, CNG Producing Company. CNG proposes to purchase certain onshore oil and gas operations from a non-affiliate seller; Consolidated proposes to purchase up to 1.2 million shares of CNG common stock, \$100 par value, at par; Consolidated will make an open account advance of not more than \$65 million to CNG; and Consolidated will make short-term borrowings of up to \$100 million in either commercial paper and/or bank loans. ### IMMEDIATE EFFECTIVENESS OF A PROPOSED RULE CHANGE

A rule change filed by National Securities Clearing Corporation (SR-NSCC-84-14) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The proposed rule change amends NSCC's procedures notifying its members of excess clearing fund deposits. (Rel. 34-21637)

## APPROVAL OF PROPOSED RULE CHANGES

## ACQUISITIONS OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
