CIVIL PROCEEDINGS

SECURITY NATIONAL BANCORP, WESLEY GODFREY, JR. PERMANENTLY ENJOINED

The Commission today announced that U.S. District Judge Royce Lamberth for the District of Columbia permanently enjoined Security National Bancorp, Inc. from violating Sections 10(b) and 13(a) of the Securities Exchange Act and Rules 12b-20, 13a-1, and 13a-11. Wesley Godfrey, Jr., president of SNBI, also was permanently enjoined from violating Sections 10(b), 13(d), and 16(a) of the Exchange Act and Rules 10b-5, 13d-1, and 16a-1 thereunder, and from aiding and abetting violations of Section 13(a) and Rules 12b-20, 13a-1, and 13a-11. SNBI and Godfrey consented to the entry of the respective Orders, without admitting or denying the facts alleged in the Complaint. Godfrey, personally, was ordered to comply with his filing obligations under Sections 13(d) and 16(a) of the Exchange Act by filing with the Commission a Schedule 13D, a Form 3, and Forms 4 disclosing his beneficial ownership of SNBI stock. In addition, SNBI was ordered to comply and Godfrey ordered to cause SNBI to comply with its filing and reporting obligations under the Exchange Act. [SEC v. INVESTMENT COMPANY ACT RELEASES

CROSS-MARKET OPPORTUNITY FUND

TRUST INDENTURE ACT RELEASES

The Commission has issued a notice giving interested persons until May 1 to request a hearing on an application by USAir, Inc. (Company), a Delaware corporation, under Section 310(b)(1)(ii) of the Trust Indenture Act, declaring that the trusteeship of Meridian Trust Company under thirty-three indentures of the Company is not so likely to involve a material conflict of interest as to make it necessary in the public interest or for the protection of investors to disqualify Meridian Trust Company from acting as trustee under each such indenture. ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
