LISTING, DELISTING AND UNLISTED TRADING ACTIONS

WITHDRAWAL SOUGHT

A notice has been issued giving interested persons until December 23 to comment on the application of PAXAR Corporation to withdraw its Common Stock, \$.10 Par Value, from listing and registration on the American Stock Exchange. (Rel. 34-31548)

UNLISTED TRADING PRIVILEGES SOUGHT

Notices have been issued giving interested persons until December 22 to comment on the applications of five exchanges for unlisted trading privileges in issues which are listed and registered on one or more other national securities exchange and are reported in the consolidated transaction reporting system. SELF-REGULATORY ORGANIZATIONS

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGES

The Options Clearing Corporation filed a proposed rule change (SR-OCC-92-36) relating to a fee revision. The proposed rule change became effective upon filing with the Commission. Publication of the proposal is expected in the Federal Register during the week of December 7. (Rel. 34-31546)

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-92-47) that became effective upon filing with the Commission. The purpose of the rule change was to notify the SEC of the reclassification of 538 National Market System securities within the maximum Small Order Execution System order size tier levels. Publication of the proposal is expected in the Federal Register during the week of December 7. (Rel. 34-31555)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change (SR-NASD-92-14) submitted by the National Association of Securities Dealers that amends Article III, Section 15 of the NASD Rules of Fair Practice. The rule change exempts the use of negative response letters in connection with the bulk exchange of money market mutual funds in certain situations. (Rel. 34-31558)

PROPOSED RULE CHANGE

The National Association of Securities Dealers filed a proposed rule change (SR-NASD-92-45) that would place quotation requirements for participants in the Fixed Income Pricing System (FIPS) and trade reporting requirements for members trading high yield fixed income securities. Publication of the proposal is expected in the Federal Register during the week of December 7. (Rel. 34-31561)

Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
