## ADMINISTRATIVE PROCEEDINGS

### PROCEEDINGS AGAINST INVESTMENT ADVISER AND ASSOCIATED PERSON

The Commission announced the entry on January 22 of an Order Instituting Proceedings, Making Findings and Imposing Remedial Sanctions pursuant to Section 9 of the Investment Company Act of 1940 (ICA) and Section 203 of the Investment Advisers Act of 1940 (IAA) against a registered investment adviser, USAA Investment Management Co. (IMCO), and a person formerly associated with the adviser, Steven D. Harrop. IMCO and Mr. Harrop were charged with aiding and abetting violations of ICA Rule 22c-1, and violations of ICA Section 34(b), resulting from purchases of approximately \$178 million of unrated securities by USAA Tax Exempt Fund, Inc. (TEFI) during 1989 and 1990. These violations were discovered during a routine examination of TEFI's Tax Exempt Money Market Fund in November and December 1990.

IMCO and Mr. Harrop both consented to the order without admitting or denying any of the violations set out therein. IMCO agreed to be censured for its violations; to comply with adopted procedures concerning specific ICA requirements and supervision of its employees; and to payment of a civil penalty of \$50,000. Mr. Harrop agreed to be censured for his violations; to payment of a civil penalty of \$5,000; and to cease and desist from future violations of these provisions. (Rel. IC-19224; IA-1359)

## CIVIL PROCEEDINGS

### INJUNCTIVE ACTION FILED AGAINST F.N. WOLF & CO., INC. AND HIBBARD BROWN & CO., INC.

The Chicago Regional Office filed a complaint on January 19 in the U.S. District Court for the Southern District of New York seeking to preliminarily and permanently enjoin F.N. Wolf & Co., Inc. and Hibbard Brown & Co., Inc. from further violations of the antifraud provisions of the federal securities laws. The complaint alleges, in part, that in connection with the offer and sale of the securities of Treats International Enterprises, Inc. that Wolf and Hibbard used high pressure, "boiler room," sales techniques based on firm-generated and distributed sales scripts and research reports which contained numerous material misrepresentations and omissions about Treats, which were known by each firm's management. In addition, the complaint seeks other equitable relief and civil penalties including an accounting, preservation of assets and the appointment of individual consultants to review each firm's policies and procedures.
