### COMMISSION REVISES PROCEDURE FOR BUSINESS NOT REQUIRING JOINT DELIBERATION

The Commission has approved minor changes to Rules 41 and 42 of its rules governing disposition of business (17 C.F.R. Sections 200.41 - 42) in order to more closely reflect its current practices. The changes specify that the Commission may delegate approval of formal orders of private investigation to a duty officer, and may treat a matter disposed of by seriatim voting as adopted by the Commission only after all Commission members have voted or reported their intention not to participate. ## ENFORCEMENT PROCEEDINGS

---

### CEASE AND DESIST ORDER ENTERED AGAINST PORTER MCKINNON

The Commission announced the issuance of an Order pursuant to Section 21C of the Securities Exchange Act of 1934 (Exchange Act) against Porter C. McKinnon (McKinnon), requiring McKinnon to permanently cease and desist from committing or causing any violation of, or any future violation of, Sections 13(g) and 16(a) of the Exchange Act and Rules 13d-1, 13d-2, 16a-2 and 16a-3 promulgated thereunder. McKinnon, without admitting or denying the allegations in the Commission's Order, consented to its entry. McKinnon of Stamford, Connecticut is a director and more than five percent beneficial owner of ABS Industries, Inc. (ABS). The Order finds that for periods up to twelve years and four months McKinnon failed to file a Schedule 13G and twelve amendments thereto for his ownership of ABS stock, and that for periods up to four years and three months McKinnon filed late thirty-seven Forms 4 and two Forms 5 for transactions in ABS stock involving a combined value of \$1,068,814. ABS's shares are traded on the National Association of Securities Dealers Inc. National Market System. (Rel. 34-34870)

## GARY WILLIKY ENJOINED

The Commission announced that on October 4 the United States District Court for the Northern District of Texas entered an Order of Permanent Injunction and Other Equitable Relief (Order) against Gary S. Williky (Williky) enjoining him from future violations of the antifraud provisions of the federal securities laws. The Order also directed Williky to pay disgorgement and a civil penalty in amounts to be determined by agreement of the parties, or by the Court. Williky consented to the entry of the Order without admitting or denying the allegations in the Commission's complaint.

The Commission's complaint, filed September 30, 1994, alleged that Williky engaged in the fraudulent offer and sale of securities of four speculative companies through Chelsea Street Securities, Inc., a former registered broker-dealer, which Williky controlled. The complaint further alleged that Williky and salesman under his control engaged in undisclosed manipulative sales practices, including "matched" trading and "wash" purchase and sales transactions. The complaint also alleged that Williky profited through his undisclosed personal sales of the foregoing securities. [SEC v. Gary S. Williky and James J. ## INVESTMENT COMPANY ACT RELEASES

---

### LANDMARK FUNDS I, ET AL.

An order has been issued on an application filed by Landmark Funds I, et al. under Section 6(c) of the Investment Company Act for an exemption from Sections 2(a)(32), 2(a)(35), 18(f), 18(g), 18(i), and 22(d) of the Act and Rule 22c-1 thereunder. The order permits applicants to issue an unlimited number of classes of shares representing interests in the same portfolio of securities, and to assess and, under certain circumstances, waive, defer, or reduce a contingent deferred sales charge on redemptions of the shares. ### ACM INSTITUTIONAL RESERVES, INC.

An order has been issued on an application filed by ACM Institutional Reserves, Inc. under Section 6(c) of the Investment Company Act for an exemption from Rule 24f-2 under the Act. The order permits the applicant to pay a share registration fee due under Rule 24f-2 for its fiscal year ending April 30, 1994 based on net sales rather than on gross sales. (Rel. ## THE PARK AVENUE PORTFOLIO

An order has been issued on an application filed by The Park Avenue Portfolio under Section 17(b) of the Investment Company Act for an exemption from Section 17(a) of the Act, and under Section 17(d) of the Act and Rule 17d-1 thereunder permitting certain joint transactions. The order permits The Guardian U.S. Government Securities Fund series of the Portfolio to merge with The Guardian Investment Quality Bond Fund series of the Portfolio. Because of certain affiliations, the two series may not rely on Rule 17a-8 under the Act. (Rel. IC-20646 - October 21)

## THE CHASE MANHATTAN BANK, N.A.

A notice has been issued giving interested persons until November 14 to request a hearing on an application by The Chase Manhattan Bank, N.A. (Chase) for an order granting an exemption from Section 17(f) of the Act to let Chase maintain securities of United States registered investment companies for which it serves as custodian or subcustodian with The Chase Manhattan Bank (M) Berhad, an indirect subsidiary of Chase located in Malaysia. ## HOLDING COMPANY ACT RELEASES

---

### CINERGY CORP.

A memorandum opinion and order has been issued authorizing a proposal by CINergy Corp. (CINergy), a Delaware corporation not currently subject to the Act. The order authorizes the proposed combination of Cincinnati Gas & Electric Company (CG&E), an Ohio combination electric and gas public-utility holding company exempt from registration under Section 3(a)(2) pursuant to Rule 2, and PSI Resources, Inc. (PSI), an Indiana public-utility holding company exempt from registration under Section 3(a)(1) pursuant to Rule 2, by which CG&E and PSI's electric public-utility subsidiary, PSI Energy, Inc., would become wholly owned subsidiaries of CINergy. Following the transaction, CINergy will register under Section 5 of the Act. CINergy also sought and received approvals in connection with the services to be rendered by CINergy Services, Inc., CINergy's newly formed service company, the formation of a new CINergy subsidiary that will hold certain of the CINergy system's nonutility assets, and the issuance of 10 million shares of CINergy common stock, par value \$ .01 per share, through December 31, 1995 for CINergy's dividend reinvestment and employee benefit plans. The Commission reserved jurisdiction for up to three years over the proposed acquisition by CINergy of the gas properties of CG&E and the nonutility interests of CG&E and PSI. (Rel. 35-26146)

### PROPOSED AMENDMENT TO THE OPTIONS PRICE REPORTING AUTHORITY'S NATIONAL MARKET SYSTEM PLAN

The Options Price Reporting Authority filed with the Commission pursuant to Rule 11Aa3-2 under the Securities Exchange Act of 1934, an amendment to its National Market System Plan for the purpose of establishing a fee to be paid by persons other than vendors who provide a data control service to OPRA subscribers and exempting subscribers who receive the feed from OPRA's Subscriber Indirect Access Fee. Publication of the Release in the Federal Register is expected during the week of October 24. (Rel. 34-34860; International Series Rel. 733)

### ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved on an accelerated basis a proposed rule change filed by the National Securities Clearing Corporation (SR-NSCC-94-16) to modify the comparison procedures for corporate bond and unit investment trust transactions and modifies the fee structure for correction fees accordingly.
