ENFORCEMENT PROCEEDINGS

DECISION DENYING LEON GREENBLATT III ACCESS TO EXCHANGE FLOOR REMANDED TO EXCHANGE

The Commission remanded a decision of the Chicago Stock Exchange, Inc. revoking Leon A. Greenblatt III of Chicago, Illinois access to the floor of the Exchange. The Exchange had found that Greenblatt had acted in an abusive and disruptive manner while on the trading floor.

The Commission found that it had jurisdiction over Greenblatt's appeal as a denial of access pursuant to Section 19(d) of the Securities Exchange Act of 1934. The Commission noted that Greenblatt was given no notice of the charges against him and neither permitted to address the Exchange's Floor Procedure Committee nor afforded any right to appeal by the Exchange. The Commission therefore remanded the matter to the Exchange to review the procedures that it employed, as well as the merits of the Exchange's action. (Rel. 34-34953)

TEMPORARY RESTRAINING ORDER ENTERED AGAINST BASIC ENERGY AND AFFILIATED RESOURCES, INC., MID AMERICA RESOURCES, INC., MICHAEL SCHOUMAN, SARAH DELANEY, ROBERT VECCHIONI, GUS ZOPPI, JR., CHARLES MICHAEL, JR. AND SCOTT SOWLES

The Commission announced that on November 2 the United States District Court for the Eastern District of Michigan issued a Temporary Restraining Order (Order) against Basic Energy and Affiliated Resources, Inc. (BEAR), Mid America Resources Corporation (MARC), Michael Schouman (Schouman), Sarah Delaney (Delaney), Robert Vecchioni (Vecchioni), Gus Zoppi, Jr. (Zoppi), Charles Michael, Jr. (Michael), and Scott Sowles (Sowles) enjoining them from violating the antifraud and securities registration provisions of the federal securities laws. Additionally, the Order froze the Defendant's assets.

The Commission's complaint alleges that, from at least January 1992 to the present, BEAR, MARC, Schouman, Delaney, Vecchioni, Zoppi, Michael and Sowles have marketed at least 14 oil and gas programs (BEAR programs) through a multi-level marketing structure consisting of at least 150 marketers and have attempted to raise \$27.4 million through the BEAR programs. Furthermore, the complaint alleges that in the offer and sale of the BEAR Programs the defendants have, among other things, omitted to state material facts and made material misrepresentations to investors concerning the use of proceeds obtained from investors, the financial condition of BEAR and the risks involved in investing in the BEAR programs. Additionally, the complaint alleges that BEAR, MARC, Schouman and Delaney are engaged in a Ponzi Scheme. [SEC v. Basic Energy & Affiliated Resources, Inc., et al., E.D. INVESTMENT COMPANY ACT RELEASES

THE HONGKONG AND SHANGHAI BANKING CORPORATION LIMITED

A notice has been issued giving interested persons until December 12 to request a hearing on an application filed by The Hongkong and Shanghai Banking Corporation Limited for a conditional order under Section 6(c) of the Investment Company Act. The order would grant an exemption from Section 17(f) of the Act to permit registered investment companies (other than investment companies registered under Section 7(d) of the Act) to maintain custody of their foreign securities and other assets with The British Bank of the Middle East and Hongkong Bank of Australia Limited. GREAT HALL INVESTMENT FUNDS, INC., ET AL.

An order has been issued on an application filed by Great Hall Investment Funds, Inc., et al. under Section 6(c) of the Investment Company Act for an exemption from Sections 2(a)(32), 2(a)(35), 18(f)(1), 18(g), 18(i), 22(c), and 22(d) of the Act, and Rule 22c-1 thereunder. The order permits investment companies to offer an unlimited number of classes of shares representing interests in the same portfolio of securities, and to assess and, under certain circumstances, waive a contingent deferred sales charge.
