RULES AND RELATED MATTERS

EXTENSION OF COMMENT PERIOD FOR THE CONCEPT RELEASE REGARDING REGULATION OF EXCHANGES

The Commission extended the comment period for the concept release regarding the regulation of exchanges (Securities Exchange Act Release No. 38672 (May 23, 1997), 62 FR 30485 (June 4, 1997)). The comment period has been extended from September 2, 1997, until October 3, 1997. (Rel. 34-38860; IS-1093; File No. S7-16-97)

ENFORCEMENT PROCEEDINGS

COMMISSION APPROVES REFCO DISTRIBUTION PLAN

The Commission approved a plan by Refco Securities, Inc. (Refco) to distribute \$3,250,000 to the defrauded clients of Steven D. Wymer (Wymer). Between 1987 and 1991, Wymer, a California-based investment adviser, perpetrated a series of schemes that resulted in his clients losing approximately \$81 million. Refco was the principal broker-dealer that Wymer used to maintain client accounts in connection with his investment advisory business. The plan was submitted by Refco pursuant to its settlement of an administrative proceeding instituted on August 6, 1996. (Rel. 34-38855)

DECISION SANCTIONING ALEX SHINDMAN FINAL

The decision of an administrative law judge imposing sanctions on Alex David Shindman of Brooklyn, New York and Boca Raton, Florida has become final. Shindman was a registered representative of M. Rimson & Co., Inc., formerly a New York City broker-dealer. The law judge's order bars Shindman from association with any broker, dealer, or member of a national securities exchange or registered securities association; bars Shindman from participation in any offering of penny stock; fines Shindman \$400,000; directs Shindman to disgorge \$2,848.13 plus prejudgment interest; and orders Shindman to cease and desist from further violations.

The law judge found that, in 1994 and 1995, Shindman committed egregious violations of antifraud provisions and aided and abetted recordkeeping violations by Rimson. Shindman ran a boiler room operation at Rimson, directing a group of unregistered salesmen who cold-called prospective customers, falsely identified themselves as Shindman, and solicited purchases of speculative securities using high pressure sales tactics and scripted sales pitches that contained baseless price predictions and other material misrepresentations. Shindman himself made fraudulent representations to customers. The law judge also found that new account forms and order tickets relating to the unregistered salesmen's customers and their transactions were falsified to reflect that Shindman was the responsible salesman. HOLDING COMPANY ACT RELEASES

GPU NUCLEAR, INC., ET AL.

An order has been issued authorizing a proposal by GPU, Inc. (GPU), a registered holding company, its electric utility subsidiary companies, Jersey Central Power & Light Company, Metropolitan Edison Company, and Pennsylvania Electric Company, two non-utility subsidiary companies of GPU, GPU Service, Inc., and GPU

International, Inc. (GPU International), and a utility subsidiary company of GPU that is also a service company, GPU Generation, Inc. (GPUG), for GPUG to provide services for (i) exempt wholesale generators (EWGs), (ii) foreign utility companies (FUCOs), (iii) GPU companies that directly or indirectly, and exclusively, own and hold the interests and securities of one or more FUCOs and/or EWGs and in project development activities related to the acquisition of such securities and their related projects, and (iv) GPU International or its subsidiaries. APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the Government Securities Clearing Corporation (SR-GSCC-97-01) regarding off-the-market transactions. Publication of the order approving the rule change is expected in the Federal Register during the week of July 21. (Rel. 34-38847)

WITHDRAWAL SOUGHT

A notice has been issued giving interested persons until August 11 to comment on the application of Reynolds Metals Company to withdraw from listing and registration on the Chicago Stock Exchange, its Common Stock, Without Par Value and its Preferred Stock Purchase Rights. (Rel. 34-38854)
