## ENFORCEMENT PROCEEDINGS

---

### PENNY STOCK BAR ENTERED AGAINST JAMES STAPLES

On July 1, the Commission instituted administrative proceedings against James T. Staples (Staples). The Commission simultaneously accepted Staples' Offer of Settlement, providing for an Order barring him from participation in any offering of a penny stock. The Order Instituting Proceedings alleges that on March 2, 1999, a final judgment of permanent injunction was entered, by consent, against Staples, permanently enjoining him from violations of Sections 5(a), 5(c) and 17(a) of the Securities Act of 1933, Section 10(b) of the Exchange Act, and Rule 10b-5 thereunder [SEC v. James T. Staples, et al., Civil Action No. 98-1061-CIV-22C, M.D. Fla.]. The Order further alleges that between at least 1994 and 1996, while Chief Executive Officer and president of LSI Holdings, Inc. f/k/a Legend Sports, Inc. and, its subsidiary, Legend Sports, Inc. f/k/a Serrine & Associates, Inc. (Legend Sports), Staples defrauded investors by operating a Ponzi scheme and by making misrepresentations concerning, among other things, the financial condition of Legend Sports, the use of investor funds and the safety of the securities offered and sold by Legend Sports. ## INVESTMENT COMPANY ACT RELEASES

### MERCURY ASSET MANAGEMENT INTERNATIONAL LTD. AND MERCURY ASSET MANAGEMENT V.I. FUNDS, INC.

An order has been issued on an application filed by Mercury Asset Management International Ltd. and Mercury Asset Management V.I. Funds, Inc. to amend two existing orders to permit additional entities to rely on the orders. (Rel. IC-23887 - July 1)

### FIRST DEFINED PORTFOLIO FUND LLC

An order has been issued pursuant to Section 6(c) of the Investment Company Act concerning First Defined Portfolio Fund LLC and any

other open-end investment company or series thereof advised by First Trust Advisors L.P. or any entity controlled by or under common control with First Trust Advisors L.P. that follows the same investment strategy as the Target 10 Series, the Target 5 Series, or the Global Target 15 Series. The order exempts applicants from the provisions of Section 12(d)(3) of the 1940 Act to the extent necessary to permit the Target 10 Series to invest up to 10.5%, the Target 5 Series to invest up to 20.5%, and the Global Target 15 Series to invest up to 7.5% of their respective total assets in securities of issuers that derive more than 15% of their gross revenues from securities related activities. ### ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change submitted by the New York Stock Exchange (SR-NYSE-99-11) under Rule 19b-4 of the Securities Exchange Act of 1934 amending the definition of volatile periods in the Exchange's specialist capital utilization measure. Publication in the Federal Register is expected during the week of July 5. (Rel. 34-41570)
