ENFORCEMENT PROCEEDINGS

DISTRICT COURT ENTERS DEFAULT JUDGMENT AGAINST COMPANY FOR FAILING TO FILE REPORTS WITH THE COMMISSION

The Commission announced that on October 6, 1999, the United States District Court for the District of Columbia entered a default judgment against Equisure, Inc. (Equisure), a Minneapolis based corporation. The Commission's complaint alleged that Equisure failed to file annual reports for the fiscal years ending December 31, 1996 and December 31, 1997. Additionally, the Commission's complaint alleged that Equisure failed to file quarterly reports for the fiscal quarters ending March 31, 1998 and June 30, 1998, and the company failed to file a report with the Commission disclosing the resignation of its public accountants in October 1997.

The court's order permanently enjoins Equisure from future violations of Section 13(a) of the Exchange Act and Rules 12b-25, 13a-1, 13a-11, and 13a-13 thereunder. The Court's order also requires Equisure to take the following remedial measures: Equisure must file its annual report with the Commission on Form 10-K for the fiscal years 1996 and 1997; Equisure must file a Form 8-K with the Commission disclosing the resignation of its auditors; Equisure must file with the Commission quarterly reports on Form 10-Q for the fiscal quarters ending March 31, 1998 and June 30, 1998; and Equisure must file with the Commission any periodic or current reports that became due prior to the entry of the court's order. INVESTMENT COMPANY ACT RELEASES

AMERICAN GENERAL ANNUITY INSURANCE COMPANY, ET AL.

A notice has been issued giving interested persons until December 20 to request a hearing on an application filed by American General Annuity Insurance Company (AGAIC), A.G. Separate Account A (Account), A.G. Series Trust and American General Series Portfolio Company. Applicants seek an order under Section 26(b) of the Investment Company Act approving the proposed substitution of shares

of American General Series Portfolio Company, OCC Accumulation Trust, and Van Kampen Life Investment Trust for shares of comparable series of A.G. Series Trust held by the Account to fund certain individual fixed and variable deferred annuity contracts issued by AGAIC. Applicants also seek an order under Section 17(b) of the Act granting exemptions from Section 17(a) to permit certain in-kind redemption and purchase transactions in connection with the substitutions. SELF-REGULATORY ORGANIZATIONS

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change, on an accelerated basis, filed by the Options Clearing Corporation (SR-OCC-99-13) that allows OCC to set earlier cut-off times when OCC's participant exchanges close early. Publication of the proposal is expected in the Federal Register during the week of November 29. (Rel. 34-42164)
