### ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission granted accelerated approval to a proposed rule change submitted by the New York Stock Exchange (SR-NYSE-99-41) under Rule 19b-4 of the Securities Exchange Act to amend paragraph 902.02 of the Exchange's Listed Company Manual. Publication of the proposal is expected in the Federal Register during the week of January 3, 2000. (Rel. 34-42270)

The Commission granted accelerated approval of a proposed rule change (SR-NSCC-99-12) filed by the National Securities Clearing Corporation under Section 19(b) of the Securities Exchange Act. The proposed rule change will allow NSCC to offer the Global Clearance Network and the International Link Service previously offered by the International Securities Clearing Corporation. (Rel. 34-42273)

The Commission granted accelerated approval of a proposed rule change (SR-ISCC-99-01) filed by the International Securities Clearing Corporation under Section 19(b) of the Securities Exchange Act. Under the proposed rule change, ISCC will transfer its clearance and settlement services to the National Securities Clearing Corporation and will withdraw from the clearing agency business.
