INVESTMENT COMPANY ACT RELEASES

ALEXANDER HAMILTON LIFE INSURANCE COMPANY OF AMERICA, ET AL.

A notice has been issued giving interested persons until April 27 to request a hearing on an application filed by Alexander Hamilton Life Insurance Company of America, Alexander Hamilton Variable Annuity Separate Account, Jefferson Pilot Financial Insurance Company, JPF Separate Account A, JPF Separate Account C, Jefferson Pilot LifeAmerica Insurance Company, JPF Separate Account B, Jefferson-Pilot Life Insurance Company, Jefferson-Pilot Separate Account A and Jefferson Pilot Investment Advisory Corporation (collectively, Applicants) The Applicants seek an order pursuant to Section 26(b) of the Investment Company Act approving the substitution of shares of the S&P 500 Index Portfolio of the Jefferson Pilot Variable Fund, Inc. (JPVF 500 Portfolio) for shares of the Fidelity Index 500 Portfolio of the Fidelity Variable Insurance Products Fund II (Fidelity 500 Portfolio). In addition, the Applicants request an order pursuant to Section 17(b) of the Act exempting them from Section 17(a) of the Act to the extent necessary to permit the Applicants to carry out the substitution by means of in-kind redemption and purchase transactions. CALAMOS ADVISORS TRUST, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting Calamos Advisors Trust (Fund) and Calamos Asset Management, Inc. (Calamos) from the provisions of Sections 9(a), 13(a), 15(a) and 15(b) of the Act, and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder, to permit shares of any current or future series of the Fund designed to fund insurance products and shares of any other investment company or series thereof now or in the future registered under the Act that is designed to fund insurance products and for which Calamos, or any of its affiliates, may serve in the future, as investment adviser, administrator, manager, principal underwriter, or sponsor (the Fund, together with such other investment companies are referred to, collectively, as the "Funds") to be sold to and held by (1) variable annuity and variable life insurance separate accounts of both affiliated and unaffiliated life insurance companies and (2) qualified pension and retirement plans.
