On November 17, 1992, the NYRO commenced a civil injunctive action against Avellino & Bienes ("A&B"), Frank J. Avellino ("Avellino") and Michael S. Bienes ("Bienes") in the United States District Court for the Southern District of New York. SEC v. Avellino & Bienes, Frank J. Avellino, and Michael S. Bienes, 92 Civ. 8314 (JES) (S.D.N.Y. November 17, 1992). The Complaint alleged that from at least in or about 1984 to in or about November 1992, A&B operated as an unregistered investment company, issuing and selling unregistered securities in the form of demand notes to the public in violation of Sections 5(a) and 5(c) of the Securities Act and Section 7 of the Investment Company Act. As of November 1992, there were approximately 3,200 investors who had invested with A&B through the purchase of A&B's securities; and the total amount of money A&B raised through the sale of A&B's unregistered securities was in excess of \$400 million.

On the same date that the NYRO commenced the action against the Defendants, the Honorable Kenneth Conboy, United States District Court, Southern District of New York, issued an Order of Preliminary Injunction and Other Equitable Relief on Consent ("Order") which preliminarily enjoined the Defendants from engaging in further violations of the above provisions of the federal securities laws. A trustee and an accounting firm were appointed to conduct an audit and to oversee the liquidation of A&B's brokerage accounts and the redemption of the note holders. The trustee redeemed all of the notes. The auditors did not uncover any fraud.

On September 7, 1993, the Honorable John E. Sprizzo, District Judge for the Southern District of New York, permanently enjoined, by consent, A&B, Avellino, and Bienes from further violations of Sections 5(a) and 5(c) of the Securities Act of 1933 and Section 7 of the Investment Company Act of 1940. The Order also directed A&B to pay a civil penalty in the amount of \$250,000, and Avellino and Bienes each to pay civil penalties in the amount of \$50,000. All Defendants have paid their civil penalties.

As this matter has been adequately resolved through the consent Order, the NERO recommends that this investigation be closed.

All files relating to this case have been prepared for disposition in accordance with the procedures set forth in the memorandum entitled "Disposition of Records Upon the Closing of Cases", dated August 20, 1993. No access requests or protective orders are outstanding. After consultation with the FOIA office, no FOIA concerns exist as of this date. No objection is made to the eventual destruction of the files. The files contain no category E records.
